6. That the amendment should be submitted to the Department of State in February 1 of 1989. -----




The special fees determined by the Inspector shall be paid not later than thirty (30) days after being requested by the Inspector.

The Inspector may authorize a payment plan of the special fee that should not exceed three months. The Cooperative should pay the first payment within thirty (30) days after being requested by the Inspector and the remaining in two monthly payments.
